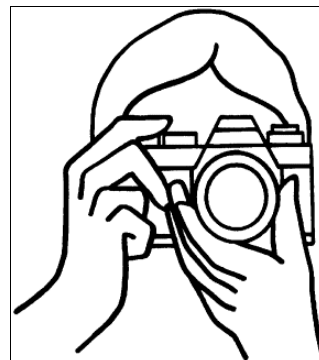

Motion to approve November 2011 Annual Membership Meeting minutes – seconded and approved.

Committee Reports

Finance Committee – Jody Billiard

- Jody provided a financial summary for November 2011.

Tennis Committee – Anne Sorrells

- We are researching the purchase of a tennis backboard. There is a quote from Courtworks, and Anne will make sure we have several quotes for this. She will also confirm the location.
- The board approved painting the fence around the upper courts.
- The wind screens on the upper courts need to be removed.
- Anne & Hank are going to look at putting silk screen advertisements on the new wind screens. If this is possible, we will sell advertising for the courts.
- Phyllis is going to look into purchasing blinds for tennis office.

Building Committee – Bob Stone

- Bob provided an update to the building project. We have revised pricing from Trehel for the bathroom/concessions building, the entry tower building, & the site work/demolition. Jody is going to meet with the bank and work out the financing.
- Mark is going to look into new signage for the club entrance.

Pool Committee

- Ken continued working with Carolina Pool Management. He has gotten positive references and the estimated cost of this from them is approximately the same as our costs last summer.
- **A motion was made to hire Carolinas Pool Management to manage and maintain our pool for 12 months. This motion was seconded and approved.**

- Mark is going to look into having some security signs made. He can get these at no cost to Windyrush.
